### OUTSTANDING (PREVIOUSLY REQUESTED) REVISIONS TO FMP DATABASE

Some "to-dos" date back as far as August 2015.

Status	Task-Description
FMP Updated 13-May-2017	– Kris "Hadene": Last name is misspelled in FMP database – Correct spelling is Hedene.
FMP Updated 13-May-2017	– William Noack – re-joined the organization – he is not a "new" member. However a new record (#3605) was created 8/29/2015 in FMP database. UPDATE already existing member record (#2438) created 6/14/2006 with recent activity and delete new (duplicate) record from FMP DB.
Still Pending	- Susan Barre: Payment entered in member's "Payments Table" as 2/9/2015—should be changed to 9/2/2015. Leave Renewal Date as is.
FMP Updated 13-May-2017	Gary Vandeman – FMP DB indicates payment made on 28 Oct 2015 (method not indicated). In keeping with SOP, renewal date would then be 28 Oct 2016. However, renewal date was recorded as 01 Nov 2015? Revise renewal date to 1 year after recorded payment date. <b>[See member-related item below.]</b> According to a 03-Mar-2016 revision to FMP DB, this individual 'renewed early' with a payment of annual dues on 11 February 2016. In keeping with SOP, the renewal date would remain true to that above. However the change in FMP DB revised renewal date to 2/11/2017!?. Revise renewal date in FMP DB back to 28 Oct PLUS the additional year [28 Oct-2017].
FMP Updated 13-May-2017	– Joan Malette – Deactivate (Annotate As Deceased) in FMP – Reported via website-based email – Deceased April 18, 2016. Record has been revised accordingly in WP-based MoZ DB.
FMP Updated 13-May-2017	– Marjorie Wilser – Notation in the comments is erroneous and pertains to a completely different member – John Novak. Delete comment in its entirety in this member's record.
FMP Updated 13-May-2017 as follows: "Was given winning raffle ticket at the 2016-04-20 but shouldn't have been given any raffle tix as his membership lapsed 6/1/2014. As 2017/-5-13 Treasurer has no record of any renewal payment."	• Gary Shapiro: As per post in List-Serve by SBAUG President K. (Goodman) Gleason: <u>"Gary Shapiro our newest returning SBAUG member... was also our grand prize winner of the \$100 Apple gift card."</u> Assuming payment of membership dues was received at the April 20 2016 Gen Mtg, <del>(verify)</del> record said payment and reactivate membership with a 20-Apr-2017 renewal date.
FMP Updated 13-May-2017	• Bettye Fue – At 4:42 PM – 0700 8/21/16, Jim Tinsley wrote: "I should mention that Bettye Fue renewed in June, but I think that I did not get her membership record updated". FMP DB does not indicate payment, however on 9/4/2016, member's renewal date was changed to 6/1/2017[?]. In keeping with SOP and By-Laws, because payment was received within 'following month' grace period after 15-May-2016, renewal date would change to 1 year hence or 15-May-2017. <b>Revise member's renewal date to May 15-2017.</b>
FMP Updated 13-May-2017	• Elizabeth (Betsy) Cramer – On 5/4/2017, FMP database was updated to reflect that renewal dues were received on 3/21/2017. This was within 'following month' grace period after 26-Feb-2017, however the member's renewal date was changed to 3/21/2018. <b>Revise member's renewal date to Feb 26-2018.</b>
