Still Pending	Audrey von Bieberstein: Contacted Webmaster/Email List Moderator for technical support to process payment of renewal dues via PayPal with iOS device (iPad). Real-time phone support provided and payment successful 5/7/2018. ^{††} Reflect payment in Member's record accordingly in FMP database (revise renewal date to one-year hence to 15-May-2019).
Still Pending	John Novak: Following eCommunications with SBAUG Website Admin, member re-joined via PayPal as evidenced by 'hit' to website's PayPal redirect 'Welcome To SBAUG' page. ^{††} Reflect payment [presume 1-yr membership] in Member's record accordingly in FMP database and revise renewal date to 03-July-2019
Still Pending	Harold Fue: On 23-Oct-2018, this Member logged into SBAUG's website and clicked on a hyperlink to submit membership dues via PayPal. IF they successfully completed the payment process, then they opted NOT to return to SBAUG website (based on lack of 'hit' recorded 'Welcome To SBAUG' page). ^{††}
Still Pending	- Kathy Gleason: Member self-reported via direct email on 22-Mar-2019 8:05 AM, that dues were submitted in Nov-2018 presumably via PayPal for one (1) year. ^{††} <u>Report verified payments received to Website/MoZ Admin</u> and revise Member's record accordingly in FMP database (revise renewal date to one-year hence to 20-Nov-2019). ^{††}
Still Pending	- Julian Dean: Contacted Website-MoZ Admin/List Moderator 26-May-19 for technical support & was informed his membership lapsed 2018. Subsequently self-reported via direct email & update to his MoZ Profile that dues submitted 28-May-2019 via PayPal w/TransID# ^{††} Annotate Member's FMP database record accordingly – change renewal date to one-year hence - 28 May 2020).
Still Pending	Member Audrey von B. contacted MoZ-MIGS Admin via email 05-Jun-2019 regarding possible delinquent annual renewal May-2019 – she was reminded via email reply to maintain MIGS status has thru 'next-month grace-period' [30-Jun-2019] and directed to PayPal link on website. No indication noted by Member that dues were actually submitted NOR notification of such from 'Acting Treasurer'. ^{††} VERIFIED via direct email to MoZAdmin on 8/1/2018 – renewal dues paid (1-yr) 6/5 via PayPal. MoZ Profile updated. Annotate Member's FMP database record accordingly – change renewal date to one-year hence – 15-May 2020).

During the May 2018 video conference w/ 'acting' Exec Board (aEB) – in so many words Ian L. (acting Treasurer) verified that for 'years' the membership database maintained within the org's WordPress (WP)-based website was the most ACCURATE/UP-TO-DATE record of memberships-status since the MoZ went online Sep-2014.¹ As such, I (aka PMR) shared the opinion that there was no justifiable reason to maintain two (2) separate membership databases² especially when via the website-based database, Members can **independently** check their membership status/history and provide/submit comments directly to Website Admin(s) regarding their membership status. The 'aEB' has since never taken the matter up and seemingly ignored taking action relative to maintaining the FMP database. While that remains pending – aEB should at least expect **-demand** better communication from Treasurer(s) to MoZ-MIGS Admin(s).
